### Order Form - *US FTA: Trading Australia Away?*

The Australian government is negotiating with the US government for a legally binding agreement to remove all trade barriers between the US and Australia. Australia has few barriers to trade in goods and agriculture. US negotiators have targeted Australian social policies like the Pharmaceutical Benefits Scheme and Australian content rules for film and television as barriers to trade.

The US is also targeting public provision and regulation of essential public services like health, education and water. It wants to remove the right of governments to limit the level of foreign investment in strategic industries like the media, telecommunications and airlines, or to use government purchasing to help local development.

Surveys show there is strong public opposition to trading away social policies and essential services in a trade agreement. This leaflet explains how we can hold our government accountable and campaign against such an agreement.
